

# Themed funding rounds

The aim of the Community Foundation for Surrey is to award grants to community and voluntary groups for charitable purposes that make a genuine difference to the lives of people in Surrey. In 2022 the Community Foundation for Surrey will be running our funding rounds a little differently so that it's easier for applicants to see what sorts of things we are hoping to fund, and for us to reach out

During December to March we will not have a particular deadline for applications but will operate a rolling programme responding to Crisis.

We will be prioritising applications for projects dealing with urgent issues arising from what we suspect will be a very tough Winter, in particular:

- Support for Afghan evacuees and other refugees
- Support for organisations tackling the impact of rising costs and falling benefits e.g. measures which improve the sustainability of food banks, or increase the ability of debt advisors to provide support.

We will also open to Emergency requests from previous grantees facing a financial crisis where a short-term award can help to bridge a gap.

Crisis and Emergency funding applications during this period will be turned around as quickly as we can, and we would aim for funding decisions to be made in a month.

The application deadlines for 2022 with be themed

- Young People supporting the range of challenges faced by young people.
- Wellbeing Advance people's wellbeing, physical and mental health and safety
- **Equity & Inclusion** Reduce disadvantage and increase access to services, strengthen community cohesion and build social capacity

Through all of our themes we are interested in capacity building and engagement with the environment.

# **Deadlines**

- Monday 25th April at 09.00 is the deadline for applications with a priority to support Young
   People with funding outcomes expected July/August.
- Monday 25th July at 09.00 is the deadline for applications with a priority to support
   Wellbeing & Health with funding outcomes expected October/November.
- Monday 10th October at 09.00 is the deadline for applications with a priority to support Equity & Inclusion – with funding outcomes expected January/February.

It is expected that future deadlines will follow the same pattern through the year subject to review.

# Young People

- Access to sports, arts, and the environment

# Wellbeing

- Mental ill-health supporting people to cope with and manage mental health issues and enable early intervention.
- Addiction Support people with drug, alcohol, and substance abuse related issues.
- Caring responsibilities supporting people caring for others
- Reducing loneliness provide older people with opportunities to access and participate in their local community to prevent isolation
- Supporting recovery supporting therapy, advice, counselling, and practical help to aid recovery and improve lives
- Supporting families and parenting
- Addressing physical ill health and disability
- Active lifestyles promoting the benefits of healthy living and eating. Helping to counter obesity, preventable diseases, and mental ill-health.
- Domestic abuse supporting people experiencing domestic abuse by providing advice, practical help and/or temporary accommodation.

- Addressing disadvantage for specific communities.

- Advice and support to help people navigate the challenges of economic disadvantage.
- Developing the basic skills which lead to employment, including IT skills, soft skills and confidence building to overcome barriers.
- Disability supporting social inclusion for people with long-term illness or disability.
- Organisations supporting those living in deprivation through access to emergency food, home supplies, practical advice, and support.
- Supporting projects which work to prevent crime, reduce re-offending, or promote rehabilitation.
- Supporting projects which support the victims of crime.
- Promoting social cohesion.
- Supporting infrastructure and community development work to build strong communities.

# **About the Organisation**

According to the Annual Accounts March 2020, the Field Lane Foundation had £3,090,629 in unrestricted funds, equating to 5 months running costs. A financial update has been provided to show a similar financial position.

#### 194 Full time staff, 218 Part time staff, 0 Volunteers, 12 Trustees

The aim of Field Lane is to support and care for people who through disability or personal circumstances need our services. The charity enables people to lift and enrich their quality of life and constantly seeks ways to develop new responses and effective interventions. Field Lane has a Christian basis, which sets the value base for all of its work. All of its services are open to all and none are restricted except by suitability. In line with our stated aims Field Lane opened a new project in Frimley, Surrey, during the year (2019-20).

During the year Field Lane provided:

- 1. Supported housing, registered care and domiciliary support for people with learning disabilities and for those with additional mental health issues.
- 2. Supported housing and personal development for families and children who are in temporary accommodation due to homelessness or are vulnerable to becoming homeless.
- 3. Consultancy, management and back-office support for care and support services run by other charities and religious orders.

Surveys designed to assist engagement are regularly undertaken and reported to the charity Board's Quality and Development Committee. The levels of occupancy, the feedback from the satisfaction surveys and the potential long-term financial stability of the houses accommodating clients have encouraged Field Lane to continue to invest in the supported housing model.

The support for the clients in the houses is provided through our two agencies, Field Lane Care and Support, in Surrey and Southend. The Southend agency limits its services to the two Field Lane houses in the local authority area but the Surrey agency also provides services to the community and supported up to 39 clients living in their own accommodation in the locality. Both agencies operate on a spot-purchase model and income is dependent on the individual needs of each client with rates being negotiated with the local authority and the family or client.

During the year 2019-21 Field Lane ran a social club in Redhill, which was well attended and gave good profile to the charity. Unfortunately, this endeavour has been temporarily impacted by the covid crisis. There is no financial impact as this club was not revenue generating.

**Previous grant awards -** The Field Lane Foundation has had 1 grant from CFS of £5,000 in 2020, which was awarded towards a sail shade at the Wood Street Sensory Garden in Redhill. Reporting has been received on time and to a good standard.

# **Assessor's Comments**

The Field Lane Foundation is a regional charity; however, 8 of their 12 supported living projects are within Surrey, and this project is confirmed to be Surrey focused. An interview with the applicant was enlightening and very positive. This is a new venture which has been well justified, planned and has strong potential impact. The assessor recommends the project for funding.

#### Need/Issue

One of the big issues currently for our services is the continuation of our clients' education and skills development over the next two years. Due to lockdown, clients that were previously attending colleges and day centres have been unable to do so. This is an important part of our clients' development and their ability to learn skills that will enable them to go on to lead more independent lives. This programme of education and learning is central to their wellbeing. Without the stimulation provided by attending college and day centres, our clients risk falling behind in their development and the learning of life skills, which is a huge blow to their confidence and ability to live as independently as possible. The clients had all been engaged in a variety of learning activities, for example, reading and writing, IT, music, dancing, exercise and sport, crafts, cooking and other general life skills. With things changing so rapidly in a post-Covid world, there is no guarantee that the colleges and day centres our clients used to attend will reopen many of the latter are run by charitable organisations, whose futures are in abeyance. We need to build in resilience and create a buffer that will restore the certainty our clients so desperately need. Already disadvantaged by their learning disabilities and other challenging behavioural issues, not having the continuity in the education and skills development would disadvantage them further. In order for our clients to integrate successfully into their local communities, to find employment or volunteer opportunities, take part in events and enjoy an active and fulfilling life, they need ongoing stimulation and support. A regular programme of education and skills development provides this. Without it, our clients will not be able to lead more fulfilling and independent lives, which is our core aim as a charity.

# **Project/Activity Details**

We are seeking to recruit a special educational needs (SEN) teacher to work with clients across all of our Surrey projects. It is the first time Field Lane has employed a qualified SEN teacher, but we believe it would bring huge benefit to our clients, who by the nature of their learning disabilities, are finding it very difficult to cope with the immense changes to our lives forced upon us by the Coronavirus crisis and with what has become for so many of us 'the new normal'.

One of the biggest and most disruptive changes has been to their education and skills development. Our clients need opportunities to learn the skills required to be able to lead as independent and fulfilling lives as possible, which is our core purpose as a charity. Due to lockdown, these opportunities have been curtailed. Clients who were previously attending colleges and day centres have been unable to do so. Without the stimulation provided by attending college and day centres, our clients risk falling behind in their development and the learning of essential life skills.

Our solution is to directly employ a qualified SEN teacher, who would work across our eight projects in Surrey (with 50 clients). The majority of our projects are in Surrey (eight out of our 12 projects in total).

It is the first time Field Lane has employed a qualified teacher; the postholder would help shape the role, bringing to bear their own knowledge and experience. We are hoping to advertise for this post in November. The cost would be £35,403 in the first year including on costs. We would be so grateful for any help you are able to give us. The outcome for our clients in being able to continue with their education and skills development would be immense.

The SEN teaching post is vitally important so we are seeking long-term funding from local grant giving trusts whom we have worked in partnership with to date. We have already received three commitments of grant funding. We have reviewed the programme, its aims, outcomes and targets and concluded that it needs to continue to enhance the quality of life for the 50 local clients with learning disabilities and achieve enhanced social outcomes. During 2021, we are seeking time limited funding to finance the next two year period of this project to enable it to continue. During this time, we will develop and review the work to assess impact and build a case for supporting future activities and additional developments to the project if / as appropriate. This will continue a two year cyclical funding regimen to ensure that the project is delivered for as long as it is needed and as long as it delivers its target outcomes effectively.

#### Impact

Many of our clients come to live in our projects straight from larger residential colleges, specifically for people with disabilities. The step change is immense – from the 'bubble' of a college geared toward people with learning disabilities, to living in their 'own house', in the wider community, in the adult world. There is no interim step. Our clients need to continually build up their skills and to retain these by having them constantly reinforced, and stay motivated. Without the regular stimulation of attending college or a day centre they are falling behind with their development and the learning of life skills, which is a huge blow to their confidence and ability to live as independently as possible. The clients had all been engaged in a variety of learning activities, for example, reading and writing, IT, music, dancing, exercise and sport, crafts, cooking and other general life skills. We need to restore the certainty and process of learning that our clients so desperately need. A key outcome of employing a qualified SEN teacher and a positive change, will be to ensure our Surrey-based clients have continuity in their learning and skills development. They will be able to carry on with regular learning, which is so vital to developing the confidence and skills they need to live as independently as possible within their local community. Other outcomes include:

- improved mental health and/or ability to cope;
- less likely to engage in harmful, disruptive behaviours;
- access to support and training to reach their personal potential to work or volunteer;
- support, information and advice to address practical, life skill issues.

Real change often takes place in deep crises, and this moment holds the possibility that we won't return to the status quo when things return to 'normal'. While this global pandemic has deeply disruptive implications, including for education, it does not have predetermined outcomes. It will be the nature of our collective and systemic responses to these disruptions that will determine how we are affected by them. In this sense, the pandemic is also a call to renew the commitment to our Sustainable Development Goals. Ensuring that young people have the opportunity to succeed and develop the knowledge, skills, attitudes and values that will enable them to contribute to society is at the heart of our agenda at Field Lane. The current crisis has tested our ability to deal with large-scale disruptions. It is now up to us to build as its legacy a more resilient and inclusive society.

The Community Foundation for Surrey award scheme will be subject to Field Lane's tracking procedures, which include monitoring (statistical reports detailing numbers of adults with learning disabilities, age, gender and ethnicity) and evaluation systems (analysis of statistical data and ongoing feedback from Field Lane staff via meetings and direct contact) as well as annual reviews of how many clients are taught by the

SEN teacher. To measure the true impact of the initiative we will obtain annual feedback from the projects, the clients and their families, all of which would be available as part of the review process to verify that the clients have benefited from the project. Specifically, we will identify:

- a drop in the number of reportable incidents relating to Positive Behaviour Support;
- a decrease in behaviour that can challenge the service;
- an increase in the client's confidence measured through their Person Centred Plan (PCP);
- achievements in clients' short-term goals and long-term goals in their PCP.

In addition, care staff will monitor the positive impact and changes on the individual clients in their care, both informally through witnessing everyday actions and behaviour, and more formally through our reporting systems and weekly staff meetings.
