Access problems for mobility scooter users because of modified driveway crossovers.

The Town Clerk said that a resident had been hoping to be present at the meeting but was unable to attend. She gave an overview of the issues that the resident wished to raise concerning the poor state of the pavements in Horley, making it difficult for both pedestrians and mobility scooter users. In particular the resident was concerned about the gradients where householders had had

P 7128) the pavement modified to create a driveway. The resident also felt that there was very limited progress on pavement improvements in the town.

Members suggested that it would be useful if the resident could indicate specific residential roads that present access problems for mobility scooter users caused by modified vehicle crossovers or dropped kerbs. HTC would then be able to pass on the feedback to Surrey Highways for their comments and request that they consider these issues when applications are made and for future pavement improvements. The matter may also be followed up by the Horley Pavement Audit Committee (HPAC).

P 7138 Traffic speeds around 'The Acres' Neighbourhood, Langshott

The Town Clerk gave an update following the latest concerns raised by residents at Wheatfield Way. She reported that Cllr Beech had followed up the issue with the Cabinet Member for Highways. Cllr Matt Furniss and it was expected that HTC would receive a response in the next week. The residents concerned had been positive about the letter that HTC sent which had also been acknowledged by the Chief Constable who said that it was a matter for the Borough Commander. To date no further response has been received from Surrey Police. Cllr Baird has also expressed her concerns by email (copy appended to these Minutes) which the Town Clerk shared with the meeting. Cllr Baker told of his recent experiences of witnessing blatant speeding. Cllr Saunders added that the potholes added to an already dangerous situation. Cllr Hudson gave examples with photographic evidence of poor road surface patching. The Chairman thanked Members for their views, and it was noted how important it was to keep up the momentum on the concerns raised to have the issues resolved satisfactorily.

RESOLVED: noted.

P 7139 High Street Paving

The Town Clerk advised that Cllrs Baker and Beech had noted some poor reinstatement in the High Street following work undertaken by the water company, leading to the area of paving being unsightly and a trip hazard. This had been reported to both SCC and RBBC Regeneration who were following up. RBBC confirmed that they had a stock of the correct paving in storage.

Cllr Saunders gave an overview of the difficulties that residents of 'The Acres' were facing in seeking to get the roads in the development adopted by Surrey Highways. He said that residents were increasingly frustrated by the lack of progress on this issue.

Airport Matters

P 7142 GATCOM: DfT Consultation on Night Flights, Stage 2

The Planning Chairman referred to the draft response he had prepared to the Stage 2: Night Flights Restrictions consultation which had been previously circulated to Members. The DfT advised that the deadline for the consultation had been extended to **3 September 2021** after receiving requests from stakeholders to extend it to enable them incorporate evidence (expected to be available within the next three months) in their responses including the CAA's Survey of Noise Attitudes 2014: Aircraft Noise and Sleep report ("SoNA Sleep"), due to be published in the summer. Extending the consultation into early September would allow respondents more time to consider and comment in detail in light of this further research.

The Chairman suggested that the draft response be reviewed when this further information on health issues became available to see if there were additional comments that HTC would wish to add to the draft response.

Members extended a note of thanks to Cllr George for all his hard work and were generally happy with the response, agreeing that this was a good way forward.

RESOLVED: that the draft response to the DFT's 'Stage 2: Night Flights' consultation be further reviewed on receipt of additional information and the final draft be presented for approval at the Planning meeting to be held on 17 August 2021.

P 7143 GATCOM: Meeting 22 April 2021, Key Messages

The Town Clerk gave an overview of the information received on the last GATCOM meeting which had previously been circulated to Members. These included the GATCOM Steering Group's Chairman's Report, welcoming new progress status rating methodology for the *End* Noise Action Plan (NAP). An update from the Passenger Advisory Group (PAG) was also received along with recent activities of the Noise & Track Monitoring Advisory Group (NATMAG) and Noise Management Board (NMB). The Northern Runway Development Consent Order (DCO) Process was a key issue discussed under Gatwick's Growth Plans and GAL's CEO gave his commentary on the performance of Gatwick over the

P 7143) last quarter. A presentation was also received on GAL's work and engagement with the Government's Global Travel Taskforce (GTT). The next GATCOM meeting was due to be held on 16 June 2021.

RESOLVED: noted.

P 7144 GAL: Gatwick Airport Airspace Office Annual Report

The Town Clerk explained that the Gatwick Airport Airspace Office Annual Report provided detailed data on Gatwick's aircraft activity together with noise mitigation measures being followed; the noise performance rankings for each airline; a Night Flights Report; an evaluation of noise complaints; and the Noise Exposure Contour Analysis for 2020. It highlighted the fact that a substantial reduction in noise impacts was due to the reduction in flights during the pandemic.

P 7147 'Delivering Change' Refurbishment Projects - Horley Town Centre

The Town Clerk gave the following update from the recent focus group meeting with RBBC Project Managers.

Subway Refurbishment:

Network Rail (NR) had agreed in principle to the request to remove the advertising hoardings to create more light into the subway, subject to a chain link fence or gates being replaced along the railway line to

- prohibit access (apart from NR personnel) but the issue had yet to be finalised
- No further progress had been made with NR due to their reluctance to meet on site.
- NR had yet to formally relinquish the triangular piece of land for suitable landscaping which could cause delays to the programme timetable. RBBC were considering how to escalate the issues with NR to move the project forward.
- RBBC offered to undertake all drainage surveys and report their findings for NR to action, but they were unresponsive.
- ➤ RBBC were considering more formal action should matters remain outstanding and it was suggested by HTC that the local MP be contacted about extra costs incurred outside of set budgets for the projects and to involve the rail regulator.
- RBBC Project Managers were also liaising Thames Water as the manhole covers were silted up, preventing gully and underground system checks to be carried out and their drainage consultations were providing further advice.
- ➤ Since SCC is the lead authority on flooding, it was suggested by HTC that the County Council might be able to provide contact information for assistance and this would be followed up by RBBC.

High Street Car Park Development:

- ➤ RBBC's architects had proposed a design set back from the building line for a housing scheme for approximately 40 homes, 2-4 storeys high with ground floor mixed development with possibly retail and leisure facilities, plus private parking, landscaping, communal gardens and outline cycle routes from the station to the subway.
- RBBC planned to carry out testing of the ground conditions during the May Half Term week and may have to cordon-off some of the car park but there would be immediate reinstatement of the trenches afterwards. HTC would be provided with further details from RBBC once available.
- > Their ecological studies of wildlife habitats sadly did not reveal anything of particular interest in that area.
- RBBC will need to consider appropriate access and service provision carefully and NR had yet to confirm if the oil pipe identified was redundant or not.
- RBBC's Project Managers expected to have an outline sketch of the development to share at the next Focus Group meeting.
- > Subject to approval from the RBBC Executive Committee in the summer months, their plans for public engagement would be shared with HTC.

Public Realm Improvements from the Subway to the High Street:

- Landscape architects were making good progress and had met on site with the SCC and RBBC Project Managers.
- They had mapped out the High Street and pavements with a contemporary, urban design and were considering either 1-way or 2way traffic Options, depending on transport modelling and traffic surveys which were booked provisionally in June and July.
- ➤ They were keen to widen the pavements on both sides with parking moved away from High Street but keeping the disabled bays along with appropriate access for deliveries along with other options to relocate standard parking away from the High Street.

- The architects further recommended tree provision inside large containers without affecting underground utilities.
- RBBC hoped to utilise passageways into the High Street, such as, Diana Walk (subject to rights of way and ownership) to maintain the character of the local area and for accessibility.

Victoria Road and Central Car Parks - Pay-on-exit Facility:

- RBBC were awaiting a start date from BT to install the infrastructure for the ANPR system.
- The existing signage would be replaced with clear entry and exit displays.
- ➤ The agreed 30-minute free parking grace period would be implemented to increase customer footfall into the town centre and ameliorate the loss of parking in the High Street.

Community and Stakeholder Engagement:

- ➤ The RBBC Project Managers were continuing to actively pursue community engagement with both businesses and residents. Further consultations were planned to include public exhibitions.
- > HTC had offered the use of the Edmonds Hall to host public exhibitions, and this was considered helpful.

General:

➤ Further updates were also provided by HTC on progress with the proposed Horley Commercial Hub and earlier replacement signage project by the Horley Town Management Group (HTMG) since these were considered relative to the four inter-related town centre refurbishments projects through RBBC's 'Delivering Change' scheme.

A further update would be provided after the next Focus Group meeting to be held on 18 June 2021.

HORLEY PAVEMENT AUDIT COMMITTEE – Virtual Meeting on Zoom

Notes from the Virtual Meeting on Tuesday 9 February 2021

Fiona Stimpson (FS) welcomed Councillor Mike George (MG) Richard Greaves (RG), Tony Breen (TB), the remote meeting of the Horley PAC. Abdou Fatih sent his apologies. Pauline Nathan & Paul Nathan (PN) tried to join the meeting at 18.16 but were unable to due to technical issues with the sound and gave their apologies by email.

Matter Arising - from the previous meeting:

FS asked Mike George to update us on various items from our previous meeting on 9th February.

- 1. MG explained why only part of Parkhurst Road had been resurfaced. This was because Surrey County Councillor Kay Hammond had asked for Parkhurst Road to be resurfaced as many residents had complained about the state of the road surface. She had planned on spending her 'pot' of the Highways budget on the road. However, it only covered the part of the road that was resurfaced. MG reported that there are plans to finish the road, but this will depend on Highways and any emergency jobs that may have to be carried out straight away. TB commented that he is happy with the new drain that has been put in Ringley Avenue opposite his house following the MP's appeal to Surrey Highways.
- 2. MG explained that the curtilages of the properties beyond Poynes Road in Meath Green Lane come right to the edge of the road; so, it is not possible to place a pavement along this stretch of road. Concerns were raised at the time of the Horley Master Plan and the proposal for the Westvale development, when a bus route from the development was first discussed. MG explained that there was no easy solution to the problem as it would involve compulsory purchase of the land to create a pavement.
- 3. The Bus lay-by in Vicarage Lane by the entrance to the Rec is not being used as the Bus Stop. This is because the bus needs a straight stretch of raised kerbing for the powered ramp of the bus to align with the pavement enabling accessibility by wheelchairs and buggies.
- 4. The broken paving in the forecourt by the Post Office/Twin Peaks is on private land and the Council has had difficulty establishing ownership of this land and are trying to persuade the owners to carry out repairs. This is now in hand.
- 5. MG reported Local Councillors and the MP have lobbied Highways about the poor surfacing in Massetts Road and that it is due to be resurfaced in this financial year.

AOB

MG gave an update on the 'Welcome to Horley' signs. At the last meeting PN raised the issue of the poor state of the Lee Street sign and expressed an interest in taking this on. FS had asked the Town Clerk about ownership of the signs and it was established that they were assigned to the Horley Town Management Group and the Chairman of HTMG gave his permission; the Clerk wrote to PN confirming the go ahead to maintain the sign in Lee Street. MG also confirmed that the Town Council hoped to be able to make a small donation to



buy plants for the signs. The other signs around Horley will be discussed at a future Town Council committee meeting and may be other residents might like to do something similar.

MG gave a short briefing on the planning application for a proposed Aldi Store in Bonehurst Road at the old Horley Place. MG reported that the Councillors had a virtual meeting with the Aldi property & transport team, etc; they (the Aldi representatives) reported that they have a high level of local support. MG reported that the main issue is the position of the proposed store in an already busy road. He also reported that Surrey CC are monitoring the levels of traffic and acknowledge that they are reduced due to Covid and will continue to monitor traffic. MG could not comment any further on this application as it will be discussed at the next planning meeting.

RG reported that he read that the catchment area for the proposed store is The Acres and Langshott and he and a Salfords & Sidlow Parish Councillor travelled the walking (RG with his with his electric wheelchair) from Ladbroke Road up to Crossoak Lane and took some pictures showing how narrow the pavement is opposite the proposed store. Also, the Days Inn entrance has the same issues as the Chequers and the Air Balloon in that they do not have dropped kerbs; however, RG said that you can use the grass on either side of the entrance – provided it is not wet and muddy!!

MG reported that Councillor Jordan is posting the Highways Bulletin on Social Media – Lee Street is one road that is being resurfaced but no pavement works.

MG gave the committee a short briefing on the works to the High Street, the subway and the High Street Car Park. The pavement on the Gatwick Pub side of the High Street is to be widened removing the free parking bays and instead will provide a limited free parking time in the Central Street Car Park. Car Parks will move to pay on exit rather than pay on entry. These works will take place this year; it is in the Consultation phase at the moment. MG stated that it will not come out of taxpayers' Council Tax but will use Section 106 monies (Section 106 agreements are negotiated between a developer and the Council to help make new home schemes more attractive to communities. It can be used to help fund affordable housing as well as roads, parks and youth services).

RG asked if anything is being done about the Subway and being part of the National Cycle Network and cyclists are not allowed to cycle through, MG noted that because there is a bend in the subway and so you cannot see what is coming in the other direction, cyclist can go through, but they must dismount.

MG reported that Gatwick have introduced a £5 forecourt charge to go into the airport to drop off passengers for the station or the airport. This means that a taxi fare that used to be £5 from Horley to Gatwick is now £10.

There has not been an update on the public toilets.

Action: **FS to ask the Clerk for an update on the Public toilets**.

FS thanked everyone for joining the meeting and suggested that meeting again in June once we establish a free evening and whether it will be virtual or an actual meeting in the Albert Rooms – *FS to action*.

Morning Judy

I would have liked to attend tonight's planning meeting for the item about Langshott traffic issues, but unfortunately I am already committed to another meeting. Having lived just off Wheatfield Way for some 35 years, I am very familiar with its issues. However, the main problem is not general speeding, it is the bend where the Bovis part of Wheatfield Way joins the Wates part. I'm sure on the original plans, the road was designed to merge rather better than it actually does! This is a tight bend (where the accident referred to happened) and is further affected by the bus travelling south from the Acres, which is forced to be on the wrong side of the road at the bend. One measure to consider would be the widening of the bend (there is a substantial grass verge on the left, travelling south) to take the sharpness out of the bend and keep the bus in its own lane.

I spoke to many Langshott and some Acres residents recently, whilst delivering election material (basically, anyone who happened to be outside), to gauge opinion about possible traffic measures, and there is a real split of opinion. There was no support at all for more speed bumps; opinion was about 60:40 against a 20mph limit (though much stronger on the Acres, where there is already such a limit); largely positive support for vehicle-activated signs or slowing-down lines painted on the road. Time and again the dangers of the bend were cited.

There is widespread concern about HGVs turning right out of the Gatwick North Gateway. (Do I remember that we were originally assured that traffic would have to enter and leave from the A23, or did I imagine that?) and ongoing complaints about the Orchard Drive/. Crossoak Lane junction. Sorry I can't be there tonight – just wanted to share my findings. Jante
