P 7166 Earlswood Homes - Pre-Planning Proposals for Residential Development at land off Haroldslea Drive

The Town clerk updated the Committee on the online public consultation event and engagement carried out by Earlswood Homes. In addition to the 35 residents that attended the online event, more than 30 questions were asked during the session which Earlswood Homes will be responding to.

Although the exhibition was held on 06 September, the team are still keen to know residents' thoughts about the emerging proposals which continue to be displayed online at the link below. Residents will be able to submit their feedback directly to the team.

P7167 Horley Town Management Group (HTMG) Update

The Town Clerk advised that the HTMG meeting took place on 14 September 2021 and was well attended (minutes appended). She advised that the HTMG Membership was reviewed to seek to secure a good overall balance of officers, local businesses/ retailers, and community groups. The final membership is to be confirmed at the next meeting. A presentation was provided by SCC/RBBC Project Officers on the Borough's 'Delivering Change' workstream and provided an update on the four key infrastructure projects within the Town Centre. It was noted that much of the works on all four projects would be completed within the next 5 years.

The Wayfinding Signage project was also discussed and updates from RBBC are expected at the next meeting. The Planning Chairman advised the committee that he was concerned that the provision of free parking (as compensation for the removal of the existing on-street bays in Victoria Road) appeared to be less certain than previous meetings with project officers, as it was advised that discussions were ongoing with the car parks manager. Cllr Baker advised that all correspondence he had seen on the project still contained reference to it but agreed it was a detail that should not be lost as the project progresses. The next meeting would be held on 26 October, 6pm at the HTC Offices (Edmonds Hall).

RESOLVED: Noted.

Highways Matters

P 7171 Horley Pavement Audit Committee

The Chairman of the Horley Pavement Audit Committee (HPAC) gave an update from their last meeting and provided a list of defects to be raised with SCC Highways. It was noted that the hedging along Smallfield Road towards Smallfield by the 'Welcome to Horley' sign also needs reporting.

It was also noted that a number of road signs need cleaning or are hidden by trees, particularly the signs around the Longbridge Roundabout.

RESOLVED: HTC to log defects with SCC.

(Supplementary Note: it was agreed with the Planning Chairman that HPAC would be reminded of the process of logging defects with SCC themselves).

P 7172 Alleyway leading from Charlesfield Road to Horley Recreation Ground

The Town Clerk advised that initial discussions with both the County and Borough Councils had failed to establish ownership of the footpath and therefore responsibility for its maintenance. Defects have been logged with both authorities and the Borough's Street Cleansing team have added the alleyway to their list for litter clearing, however ongoing maintenance issues would require ownership to be established.

RESOLVED: HTC to undertake a land registry search of the alleyway leading from Charlesfield Road to Horley Recreation Ground to identify ownership for maintenance purposes.

P 7173 Traffic Speeds on Wheatfield Way, Langshott

Cllr Beech provided an update on his discussions with Cllr Matt Furniss, Cabinet Member for Highways and officers in the Highways Department at Surrey County Council. It was noted that due to lack of funding and the prioritisation criteria, any changes to the road layout or engineering solutions were unlikely or would take some time to be progressed.

Cllr Beech had therefore asked highways to investigate the feasibility of vehicle activated signs in order to try and reduce speeds on this stretch of road. Initial discussions with the Road Safety Manager, suggested that the best location for VAS signage would be on column 19 or 21 reflecting the survey undertaken on column 19 which showed average speeds of 35mph northbound and 34mph southbound vs 29mph recorded from column 12. The advantage of mounting it on one of the existing columns would be that there is already a power source to draw from. Cllr Beech stressed that discussions were still at an early stage and there has been no firm commitment to this.

In addition to this, ClIr Beech had requested that SLOW markings are painted on both directions of the road prior to the raised table/informal crossing and that the markings on the table are renewed as they are currently very faded. He had been advised that because there were existing cycle and road hump warning signs on both approaches to this informal crossing, SCC were able to provide SLOW markings at this location. However, there was limited funding for new signs and road markings in Reigate & Banstead and what there is has already been committed at other locations for this financial year. It was hoped that it would be arranged for these SLOW markings to be laid next financial year 2022/23 subject

to available funding. The markings on the raised table, would be inspected shortly and added on the list to be refreshed.

The Town Clerk confirmed that HTC had requested that the issue be included on the agenda for the next Reigate and Banstead Local Area Committee which is set for 1st November 2021 and that Cllrs George and Andy Lynch (SCC) would be able to make representations at the meeting if required.

RESOLVED: noted.

Lee Street Speeding Concerns

The Planning Chairman advised that two residents had now contacted him regarding speeding concerns along Lee Street, as well as excessive use of the road by HGVs. It was noted that Surrey Police had acknowledged that there may be a speeding issue along Lee Street and that they would do some monitoring.

It was noted that there had been some damage to the railings on the bridge at the bend on Lee Street. Cllr George had also contacted Cllr Lynch regarding a car that has gone over the grass near the water works.

RESOLVED: Update noted.

Precinct Paving

The Town Clerk advised that the SES Water Meter covers in the Town Centre Precinct appeared to have been reinstated flush with the paving stones.

RESOLVED: noted.

P 7176

Paving in Consort Way (Victoria Square)

The Town Clerk provided an update on the several trip hazards identified outside McColls Newsagents on the corner of Victoria Square (and other areas nearby) due to the underground London Plane Tree roots pushing the paving upwards. Since the tree was positioned on private land, none of the principal authorities were accepting any liability.

RBBC later advised that HTC could put in an application for tree works to be undertaken. The Town Clerk responded, by advising that HTC Members were very disappointed that the LPA could not intervene to have the matter resolved and as a preventative measure to avoid serious personal injury. She advised that HTC had already taken every action possible to escalate the matter to the appropriate authorities, from carrying out a land registry search to identify the landowner, then writing to them and liaising with their contractor and putting both parties in contact with the RBBC Tree Officer but no further action was taken.

Cllr Samantha Marshall questioned whether it could be reported to the HSE but this and several other avenues had already been pursued by HTC along with Planning Enforcement and Licensing Officers but none could intervene as the area was on private land. Members present considered that the matter required further legal advice and this would be followed up accordingly.

RESOLVED: that a further update on the Paving in Consort Way (Victoria Square), be provided at a subsequent meeting of the Planning & Development Committee).

Airport Matters

GAL: Proposals by Gatwick Airport to bring its Northern Runway into routine use alongside its Main Runway and the DCO Process (Closing Date: 1 December 2021)

The Town Clerk advised that there were several opportunities to review the consultation material on the Northern Runway Project including, inter alia, visiting the community information van here in the car park at the Council Offices on the following dates:

- 21 October 2pm-5pm
- 13 November 2pm-5pm

A hard copy is also located in the library.

The Planning Chairman advised that he had undertaken an initial review of some of the material, which had identified that Church Meadows was proposed to be used as a balancing Pond, part of the A23 (bordering onto Riverside Garden Park) is to be cut away to support highway works, a new express filter lane was proposed at the Longbridge Roundabout and a new flyover is proposed for the South Terminal. The Chairman advised that the project was not expected to be completed until 2032, so a 10 year + programme of works, not all of which were contained within the existing confines of the airport boundary, would thereby have a potentially significant impact on Horley.

It was also noted that land owned by SCC and/or RBBC which is currently allocated for the new business park is proposed to be used as a contractor works unit which could delay any proposals for the business park, as well as having a potential impact on residents due to operating hours (24/7).

The Planning Chairman proposed that a working group is established to ensure all material can be covered and a response drafted. The 4 key issues he identified are:

- Surface Access
- Flooding
- Noise
- Air Quality

Cllr Stimpson and Cllr Baker volunteered to assist the Planning Chairman. It was also suggested that Cllr Saunders be approached.

The Planning Chairman advised that he will be liaising with RBBC regarding specific topics but that initially Leon Hibbs (RBBC) had advised he is happy to discuss Air Quality and Noise. It was noted that Ian Dunsford (RBBC Head of Policy) and Cllr Richard Biggs (Portfolio Holder) would be leading on the Borough Council's statutory consultee response.

RESOLVED: A draft response is to be presented for discussion at the Planning and Development Committee in November 2021.

1 Apologies for Absence

Apologies were received from Chris Hancock ('The Bull 'Public House), Cllr Jordan Beech (SCC/HTC), Simon Bland (RBBC), Diane Dunkley (RBBC), Cllr Rob Spencer (HTC), Chris Sharville (Horley Online).

2 Constitution

- i) Andy Lynch (AL) was elected as Chairman until April 2022 (SM proposed and FS seconded).
- ii) Chris Hancock was elected as Vice-Chairman until April 2022 (AL proposed and SM seconded).
- iii) The HTMG Membership was reviewed. MS suggested inviting the Horley Health Alliance (Horley Health Hub) to have a representative. MH agreed to ask whether any members of the HCoC would wish to have representatives on HTMG to increase the number of representatives from the business, retail/trader sector. It was also suggested that Tony Freeman (RBBC Community Development Worker) and Natalie Hughes (Horley YMCA Centre Manager) be contacted to consider joining the group.

ACTION: HTMG Membership to be confirmed at the next meeting.

- iv) It was agreed that all other sections of the Terms of Reference to remain as originally drafted (copy appended).
- v) JW advised that the HTMG Bank Account with HSBC requires up to date signatories in order to ensure that future funds can be accessed. She alerted Members to the fact that dormant Bank Accounts would cause problems for future access unless regular transactions were being carried out which had not been the case previously. She added that there may be other options to consider, such as closing the HTMG Bank Account with HSBC and entrusting the funds to HTC to manage through

a separate earmarked fund, subject to a letter of authority being provided by the HTMG Chairman. The matter would be followed up and agreed at the next meeting.

ACTION: HTC to follow up on possible options for future banking arrangements by HTMG, for agreement at the next meeting.

3 'Delivering Change' Refurbishment Projects and Public Realm Works in Horley Town Centre

A presentation was provided by SCC/RBBC Project Officers highlighting the new community-led model proposed towards the economic, social and cultural renewal of Horley (post-COVID). A decision is pending on their bid for funding from the Community Renewal Fund, however, SCC are committed to moving forward on the new model.

CR presented the Borough's 'Delivering Change' workstream and outlined the 4 key projects that are being progressed, with capital funding principally coming from existing \$106 money.

3.1 A refurbished subway

CR advised that RBBC are continuing discussions with Network Rail and that survey work is ongoing regarding the existing water pump/ flooding issues. A design team is in place awaiting survey results. In addition, CR advised that the advertising hoardings had been removed by Network Rail. FS made the suggestion for an extended canopy over the subway to prevent heavy rainfall from entering the subway.

3.2 <u>Public realm improvements to the High Street to address the poor-quality environment</u>

CR advised that this was part of the levelling up work to the precinct and that the scope of works covers the area from Albert Road to the Railway Bridge. Improvements being considered included pavement widening, benches, street trees etc. A design team was in place, but work has been paused pending the recommencement of traffic surveys post COVID.

3.3 <u>Installation of pay-on-exit parking in the Victoria Road and Central car parks to overcome perceived issues of parking being a barrier for town centre visitors</u>

CR advised that the car park infrastructure works were out to tender. However, there was a need for power and BT infrastructure to be installed into the site to enable the works.

MG queried whether there was potential for removing spaces from the High Street to enable pavement widening (albeit retaining accessible spaces), alongside the possibility of an initial 30 minutes' free parking. CR confirmed that all options were still being considered.

MG highlighted the discrepancies/conflicts between the recent SCC Highways consultation proposals and the RBBC proposals through the town centre. In particular, the SCC proposal to remove the right turn junction from Victoria Road to Consort Way East. CR thanked MG for highlighting these and advised that the two work streams

were now more aligned.

3.4 <u>Bringing forward the development of the underutilised High Street Car Park site to</u> deliver much needed new homes through a residential led scheme

CR advised that the design team are in place for this project and that the Borough's Site Allocation policy stipulated 40 residential units (likely to be flats) and approx. 1000sqm of non-residential ground floor space. In addition, the landscaping and public realm improvements for this site would need to be joined up with the public realm subway improvements.

CR indicated that a Public engagement/consultation on the initial designs was anticipated for Autumn 2021 but there was no fixed date as yet.

3.5 <u>Levelling Up Fund</u>

CR thanked HTC for the letters of support provided to assist this funding bid. CR advised that there was approx. £2.7million put into the project 'Your Horley' with considerable emphasis on public realm improvements. The project was split into 3 key workstreams – 'Your High Street', 'Your Victoria Road', and 'Your Services'.

An application had been made for funding to provide the installation of infrastructure/ equipment for a future market and funding for the power infrastructure to enable the installation of electric vehicle charging points in Consort Way East.

3.6 <u>Timescales</u>

CR advised that the timescales for the 4 key projects were anticipated to be as follows:

<u>Refurbished Subway</u> — Funding was available this financial year, therefore, timeline subject to outstanding discussions with Network Rail but anticipated that progress would be made before the end of 2021.

<u>Public Realm Improvements</u> – Resurfacing works to Central Car Park anticipated shortly but that consultation with wider stakeholders can begin before/ in tandem with car park works.

<u>Pay on Exit Parking Barriers</u> – Works subject to power network installation but ideally works undertaken within this financial year.

<u>High Street Car Park</u> – Initial design consultation and public engagement expected in Autumn 2021 with a planning application submitted next year.

CR anticipated that the majority of the works on all 4 of the key projects would be completed within the next 5 years.

PH explained that SCC were seeking to understand the HTMG vision for the town centre and advised that the last 3 months had been focussed on engaging with local stakeholders including, amongst others, local hotels/B&B, the Archway Theatre, Chamber of Commerce, Oakwood School, Yattendon School, Scotia Gas, Stark Energy as well as other community groups and the 'Growing Health Together' alliance.

PH explained that SCC were developing operating frameworks with Officers from across all different disciplines coming together to talk about specific locations. The idea being to pool contacts, projects, timescales, engagement events as well as establishing a set of working principles.

MS highlighted Horley's growing population as a key asset as well as the opportunities afforded by post-COVID working patterns which the town centre could capitalise on – consideration particularly focused on the proposals of a town centre business hub initiating secondary spending on other services, such as, dry cleaners, barbers/hairdressers, restaurants etc.

MS queried whether there were alternative business funding models if the funding bids weren't successful. RB advised that one option would be to utilise some of the Borough's CIL money.

MG highlighted the 'community feel' as distinctive to Horley and that he would not wish to see this lost. It was acknowledged that Horley is a centre in its own right, particularly for the communities of Hookwood and Charlwood and to an extent Smallfield.

It was agreed that a copy of the Horley Town Centre Vision (2015) Document be recirculated to all.

4 Horley Town Centre Wayfinding Signage Proposal

Discussion on the Wayfinding signage project identified that RBBC were reviewing signage locations and ensuring no gaps in the original conceptual plan. MG advised that HTC were supportive of a local contractor for the works but suggested an updated map.

MG added that there was also a strong desire for new signage to be also placed outside the town centre, in surrounding areas, should this be made possible.

A question was raised regarding the outstanding funding held by RBBC in relation to the 'Mary Portas Fund' that would be used in part to fund the new town centre signage.

ACTION: RB to check the position on the 'Mary Portas Fund' with RBBC.

FS raised concern about the proposed cycle route from the Town Centre to Meath Green Lane identified in the LCWIP and suggested an alternative route using the National Cycle route through Langshott and the Acres. However, it was acknowledged that human nature would always seek the shortest direct route, which therefore needed to be addressed.

At this juncture of the meeting, AL made a sincere note of thanks to the SCC/RBBC Project Managers (PH/CR) for being present and for providing their very comprehensive and informative briefing with reference to their PowerPoint presentation. PH confirmed that her contact details could be circulated and that SCC/RBBC were keen to retain open and ongoing dialogue. AL added that they would be welcome to attend future HTMG meetings to share further information as plans progress. PH/CR then left the meeting.

5 Planning Applications

5.1 P/A No. 21/02267/F – Barclays Bank Plc, 105 Victoria Road, Horley

It was noted that the above application for the existing signage and ATM to be removed has been registered with RBBC. A decision had not yet been determined by the Borough Council.

JW added that HTC had initiated the discussions with Barclays Bank and RBBC to agree arrangements for the mobile banking van to be brought into Horley once the branch closed on 22 October 2021 and it was understood this would be on a fortnightly basis. Further details about the facility would be provided once made available by Barclays.

5.2 P/A No. 21/02346/F – Land R/O 43-49 High Street, Horley

It was noted that the above application for residential development of 3 x Three bed house has been registered with RBBC. A decision had not yet been determined by the Borough Council.

5.3 P/A No. 19/01417/OUT – M&G Catering Equipment, 10A High Street, Horley

It was noted that the above application for the demolition of the existing building and one four storey block containing 12 x 2-bed apartments had been dismissed at appeal.

5.3 P/A No. 21/01784/CU – The Stapley Building, 24B High Street, Horley

It was noted that a change of use application for Sui Generis (hot-food takeaway) and the installation of extractor flue pipe has been registered with RBBC. A decision had not yet been determined by the Borough Council.

6 Any Other Business

6.1 Pavement Audit – Horley

FS highlighted concerns regarding the repair of the alleyway between Charlesfield Road and the Recreation Ground, particularly as it appears unclear who owns it.

It was agreed that relevant updates from the Pavement Audit Committee would remain on the HTC Planning Agenda for future meetings.

6.2 RBBC Local Business Awards

The Borough's Economic Prosperity Officer sent in a written update to advise that the business awards were being launched on 22nd September, with entries open until 4th October and the presentation event taking place on 27th January 2022.

HTMG short-listed the following four businesses for consideration in the High Street Hero category.

- Chris White Butchers
- 1st Class Flowers
- Chalk Hills Bakery (Gatwick Metro Centre)
- Dapper Shoes

ACTION: HTC to pass on to RBBC.

(Supplementary Note: HATs have been in contact with HTC and RBBC regarding the

business awards).

6.3 Defibrillator Programme

JW informed the group that HTC had recently managed the installation of another defibrillator which is now in situ outside 'The Bull' Public House after the equipment was donated by a <u>local charity</u>, <u>Rapid Relief Team</u> and this had been added to the <u>Horley Programme of Defibrillator Locations</u> originally launched by the HTMG. Further funding would need to be sort for additional defibrillators.

RB advised that funding for defibrillators for public use could be available through the

RBBC Community Small Grants Scheme and he would aim to support local groups who wished to make an application.

Additional Town Centre Retail Kiosks

It was agreed that HTC would draft a letter of support endorsing the suggestion for additional retail kiosks to be placed near the Factory Shop on Consort Way East.

ACTION: HTC to liaise with RB.

Surrey County Council Local Transport Plan 4 (LTP4) Public Consultation

Thank you for the opportunity to respond to the above-entitled consultation, I am responding on behalf of Horley Town Council. The matter was considered at our Planning Committee meeting on 21 September and the following comments are set out below:

Horley Town Council is broadly in favour of the vision and proposals set out in this latest iteration of the SCC Local Transport Plan. These include plans to reduce carbon emission levels (currently at 46%); improved walking and cycling routes, more charging points for electric vehicles, increased bus services and redesigning neighbourhoods to improve accessibility and avoid the need to travel by car. The Town Council passed a Motion declaring a <u>Climate Emergency in 2019</u> and are supportive of all measures that seek to address climate change.

The Town Council supports the aim of responding to the challenges of climate change and to addressing other sustainability issues. The Town Council supports the aim to significantly reduce transport carbon emissions to meet the net zero challenge and to support enhancement of Surrey's economy and communities, as well as the health and quality of life of residents.

The Town Council supports plans which seek to reduce the need to travel and to promote cycling, walking and public transport and make a better use of public space.

The Town Council is supportive of all residents having access to appropriate transport facilities and protection from the harmful emissions caused by traffic pollution.

Members highlighted the way we shop via out-of-town retail parks & the ongoing switch to online shopping has created car & van journeys. The increase in the latter shows no sign of reducing even after COVID restrictions have been relaxed or stopped. Horley Town Council therefore question whether one courier van doing multiple drops results in less journey miles & emissions compared to all those customers making individual journeys to the shop/supplier?

The Local Transport Plan acknowledges that the economic success of Surrey is in part due to its location bordering the two major international airports of Heathrow and Gatwick and that Surrey's local transport network and infrastructure contribute to strong national and international connectivity, which is an important driver of business location decisions within the county.

However, it is not clear from the Local Transport Plan 4 Consultation document that consideration has been given to the ambitious growth plans for Gatwick being progressed by Gatwick Airport Ltd & whether their impacts on the areas transport infrastructure, vehicle movements & impacts on air quality have been considered.

Furthermore, the Town Council seeks assurance that there will be sufficient funding to enable these proposed plans to be implemented and enforced.

We do hope that our above comments will be given due consideration and we look forward to hearing the outcomes in due course.

Thank you for notifying us of the publication of the Draft Mole Valley Local Plan (Proposed Submission Version – Regulation 19 consultation). Members of the Horley Town Council (HTC) Planning and Development Committee discussed the proposed plan at our meeting on 21st September 2021.

Whilst it was noted that the overall housing target across the plan area has been reduced, the proposed housing on the site allocations located in Hookwood have increased from 490 to 563 (a 14% increase), in large part due to the inclusion of an additional site allocation (Policy DS42: Land at Povey Cross Farm, Hookwood).

As such Horley Town Council remain gravely concerned about the impact of these proposed site allocations (now referred to as DS41, DS42, DS43 & DS44) on local infrastructure (including education, health, transport, flooding & water capacity) in Horley and consider that the comments made to the previous consultation (attached herewith) still remain applicable.

Based on the Statement of Common Ground with the surrounding authorities, HTC would question whether such cross-boundary strategic infrastructure matters have been adequately addressed for the plan period to enable the plan to be found "sound".

We trust that the attached comments will be duly received and noted.

RE: - Future Mole Valley - Draft Local Plan

Horley Town Council [HTC] welcomes the opportunity to comment on the Draft Local Plan and has considered the proposed plan at their planning meetings.

We refer to the sites you have identified as SA43/44; but in particular SA42 located in Hookwood.

Their geographical location in relation to Horley gives us grave concerns on many infrastructure matters. It is unfortunate that neither the Draft Plan nor the recent public exhibition held in Hookwood provided any information regarding supporting infrastructure.

Undoubtedly, the residents of these sites will look to Horley to meet their needs for education and health care. At present our current infrastructure is unable to meet the demands of Horley residents, let alone the increased impacts from the growth in our Horley population from the new developments within Horley.

Medical Provision

The three Horley GP practices are operating with closed lists; whilst only one of our dental practices is accepting NHS patients.

Education Provision

Though the Westvale Park development is scheduled to have a new two form entry primary school in operation from September 2020 it will be a phased opening therefore some six years before it is in full operation; similarly the primary school in The Acres opened on the same basis. This has meant that children whose ages are ahead of the phased opening are having to be accommodated in the existing schools with two of them accepting bulge years. There is also the matter of the capacity at our only comprehensive school, Oakwood, and we hope this will be addressed before children transfer from the primary ones.

Transport Infrastructure

We also have concerns about the impact SA42 will have on generating additional traffic on the already very busy A217, not to mention pressure on the road from Gatwick's growth plans.

Other Infrastructure Concerns

HTC note that at the recent Reigate & Banstead Development Management Policy Public Examination it was stated that this is a water stress area. Has this been taken into consideration?

We must also mention concerns about the impact on the Horley Treatment Works which we presume will be required to support SA42. As well as supporting Horley's growth, Gatwick has included it in their master plan. HTC question how much more this facility can take?

We note that SA42 is in flood zone 2 which will require detailed plans for flood mitigation however HTC are concerned about the potential impact to Horley of mitigation from another major development in such areas.

We feel that it is vital that Mole Valley District Council publishes an Infrastructure Development Plan as soon as possible.

We hope that you will consider our comments and concerns in the future stages of the Local Plan.
