It was clarified that costs are calculated according to a formula and the finances relating to elections are thoroughly scrutinised by the Cabinet Office. The costs are fixed according to the formula and there is no possibility of avoiding the costs or of negotiating more favourable terms if a seat is contested. As previously agreed during the Precept consideration for 2022/23 Council have not budgeted for election costs during this year and have accepted that there is a level of risk that costs may be incurred. 2023/24 is an election year for the Town Council and as the risk of a seat or seats being contested will be higher consideration will be given to allocating an amount in the budget for election costs for 2023/24.
