P 5844 Apologies and Reasons for Absence

P 5848 Virgin Media Cabinets

It was noted that a telephone update was received from Virgin Media indicating that the various cabinets in Horley where a report had been lodged would be attended to by an engineer. Virgin Media would provide a further update once this work has been completed.

P 5849 Surrey County Council - Part Night Lighting Review Request

It was noted that a response had been received to the Town Council's request for a further review at the location leading from 'The Crescent' Horley towards Gatwick Airport. The Planning Officer reported that the County Council had since advised

P 5849) that lights were not switched off where the Council's Road Safety Team or Surrey Police had concerns about the potential impact on road or community safety. Although this was not the case at 'The Crescent', it had been decided to keep the three street lights nearest the footbridge on all night. The request to keep all lights on at this particular location would also be reviewed further and the outcome notified in due course.

The SCC Street Lighting Team further advised that a total of nine review requests from the Horley area, had been received to date.

P 5850 Parking on School Zig-Zag Road Markings

The Planning Officer reported that the Horley Learning Partnership (HLP) had been approached to establish the extent of inadequate parking restrictions and obliterated road markings outside Horley schools. A prompt reply was received from the Head Teacher of Oakwood School (and Chair of HLP), advising that the matter would be added to a future meeting agenda for discussion and circulated to other Head Teachers for their feedback.

In the meantime, SCC Highways would be contacted again to ascertain when the zig-zag markings would be refreshed outside Horley Infant School, Albert Road since it had been added to the current works schedule yet remained outstanding.

RESOLVED: that a further update on the provision of parking restrictions outside Horley schools be provided at the next Committee meeting and SCC Highways be contacted to ascertain when the zig-zag markings outside Horley Infant School, Albert Road would be repainted.

However, in order to make adequate cost savings on the CRC service, a recommendation would be made to end the free daily allowance of chargeable waste.

P 5863 SCC Consultation: Pay and Conserve - Proposed Car Park Charging on Surrey County Council's Countryside

The Planning Officer reported that the above SCC consultation, led by Cabinet Member for Environment and Planning, Mike Goodman, refers to 6,500 acres of countryside estate which is open to the public and managed by Surrey Wildlife Trust on behalf of the County Council. Due to growing financial constraints on all its services and to stop deterioration of the countryside, SCC proposed to introduce parking charges in some rural car parks. The public consultation was available for comment through an SCC online survey prior to the closing date (6 November 2017), and this would also be placed on the HTC website for public information.

The Planning Officer conveyed information received from Highways England on plans to convert the M23 between junctions 8 and 10 into a smart motorway, using enhanced technology to increase capacity, relieve congestion and maintain safety. It was anticipated that works would start sometime next year.

P 5871 SCC Consultation: Proposals for existing 'No Entry' signs at Albert Road and Lumley Road

The Planning Officer reported that the results of the above SCC Consultation on proposals for the 'No Entry' signs on Albert Road and Lumley Road had been followed up by Town Council on receipt of a written enquiry from a local resident.

The results of the public consultation indicated that the majority of residents on Albert Road who completed the survey did not support removal of the 'No Entry' signs due to a possible increase in the number of vehicles using Albert Road if it were removed. However, the majority of residents on Lumley Road who completed the survey did support the removal of the 'No Entry' signs. It was also generally felt that the removal of both 'No Entry' signs could lead to an increase in traffic in both Albert Road and Lumley Road, but greater in Albert Road with vehicles exiting car parks, shops and the library.

SCC concluded that there was no overwhelming level of support for the removal of the existing 'No Entry' sign in Albert Road and only limited support for the removal of the existing 'No Entry' in Lumley Road. Taking the overall results of the consultation into account, it was recommended **not to proceed** with proposals to revoke existing one-way traffic orders and removal of existing 'No Entry' signs in Albert Road and Lumley Road and existing arrangements would therefore remain in place.
