### INTRODUCTION

This year the Town Meeting resumes to its usual April date. The election of all Horley Town Councillors took place on 5 May 2011 when members were elected for a term of four years.

Included in this publication are reports from the Chairman and Town Mayor, as well as all the statutory reports made by the Town Council's Committee Chairmen, which will all be presented at the Town Meeting on 27 April 2012. It also includes a variety of information and statistics. At the time of producing this Annual Report our accounts for 2011/12 are not yet available, but we have included financial information relating to the financial year 2010/11. The unaudited accounts for 2011/12 will be available to the public for inspection from July 2012. We expect to publish the audited Annual Return on our website in September 2012.

# STATISTICS AND INFORMATION



The Town Council is administered as a first tier local government authority in an area whose County Authority responsibilities are maintained by Surrey County Council and whose District Council responsibilities are maintained by Reigate & Banstead Borough Council.

There are approximately 22,000 people residing within the boundary of this Town Council of which 16,774 are registered electors as at 1 April 2012.

The Precept is collected on the Town Council's behalf by Reigate & Banstead Borough Council. For the fiscal year 2012/13, it is set at £295,830. This equates to a sum of £33.30 per band D household.

### FINANCE & GENERAL PURPOSES COMMITTEE REPORT

### **Committee Responsibilities**

The Committee supervises all financial, administrative and civic matters and ensures that all procedures and financial transactions are dealt with in accordance with the various statutes governing local authority activities. Accounts are checked regularly and two Councillors are rostered to conduct an audit prior to each F&GP Committee meeting. A number of Councillors serve on subcommittees and outside bodies, as described elsewhere in this Annual Report, which report back to this Committee.

### **Accounts**

The Council's accounts are run strictly in accordance with various statutory instruments and guidance received from the National Association of Local Councils. I am pleased to report that all our procedures and internal controls were conducted to the satisfaction of our internal auditor. In the opinion of BDO Stoy Hayward plc, the external auditors, our accounts again received unqualified acceptance, and we are fully in accordance with the Audit Commission's requirements. The audited balance sheet for 2010/11 showed a general reserve of £42,648.

Looking towards the end of the financial year 2011/2012, the Council accounts remain in a strong state and, at the time of preparing this report, it is expected that the general reserve will be maintained.

### Financial Year 2012/13

The precept for the year 2012/13 has been set for a total net figure of £295,830 (compared to the net figure of £287,361 for 2011/12). This means that the town element of Council Tax will be £33.30 per Band D household, an increase of only fifty pence per annum for the average household.

The Town Council fully recognises that, in these times of recession, the residents of Horley are under considerable financial pressure. We have tried to keep the precept/budget as low as we can compatible with maintaining the quality of service to the community. We cannot, however, continue draining our reserves beyond safe levels. This Council has tried to keep costs down over the last few years and is one of the cheapest Parish/Town Councils per householder for an area of equivalent size for this part of the country. We also have always tried to give very good value for money in terms of facilities and services to the residents of Horley. We will continue to try to optimise income from Edmonds Community Hall lettings and rental of allotments, football pitches etc, whilst recognising that keeping rents down as far as possible is a way of helping the community.



We continue to support the local churchyards and subsidise local facilities such as Horley Bowling Club by means of low rents. Other sports facilities such as football pitches and recreation grounds are also financed by the Town Council. These are important services for residents which the Town Council provides.






### Website

The website continues to be a valuable source of information for the local residents as well as the wider community.

### **Newsletter and Town Guide**

Quarterly issues of our newsletter, Horley Highlights, will again shortly be produced after a gap in publication which was beyond our control. This is an important method of disseminating information to Horley residents and we intend to make better use of it in the future. MAD Ideas produced a



fully revised Town Guide last summer, which was full of useful local facts and information.

### **Government Initiatives**

The Council has a Freedom of Information Act Publication Scheme, which allows members of the public access to specified Council documentation and publications. In May 2010, this Council adopted the Power of Well Being which gave the Town Council greater authority to extend its powers and potential responsibilities. This has been re-adopted by the new Council, following the election last May. We also look forward to embracing the opportunities presented by the new Localism Bill.

The Internal Audit Committee conducts regular reviews of the audit programme. In liaison with the Clerk, a structured internal audit programme has been developed.

### **Local Initiatives**

We are planning surveys into what the local residents want from the Town Council (known as a "Health Check") and researching methods of making the Council more efficient such as greater use of electronic data.

### **Devolved Powers**

Horley Town Council has entered into an agency agreement with Reigate & Banstead Borough Council for the provision of grounds maintenance services in Horley until March 2015. This has ensured that strict criteria are met including: delivering an improvement in service to the Council Tax payer, improving service resilience, making things simpler for residents to understand, and making a more inclusive service.

Since April 2010, the following sites have been phased over to Horley Town Council on an agency agreement basis:

Bay Close Open Space Church Meadows Riverside Garden Park Riverside Walk Yattendon Road Recreation Ground

### LEISURE & AMENITIES COMMITTEE REPORT



The Leisure and Amenities Committee is now responsible for looking after all the main parks in Horley. These are these are Horley Recreation Ground, Court Lodge Playing Fields, Michael Crescent Centenary Park, Emlyn Meadows, Yattendon Road Recreation Ground, Bay Close Open Space, Riverside Garden Park, Riverside Walk and Church Meadows. The last three were taken over this financial year under devolved powers from Reigate and Banstead Borough Council. These areas are now being maintained to the same specification as the rest of the Council's Parks.

The Committee's aims as ever are to maintain and upgrade all the grounds and play equipment. This work is continuing and is evident in the Memorial Gardens and the Ornamental Gardens and with phase three of the footpaths being completed in the play area and Ornamental Gardens this year, and with the recent works in Riverside Garden Park, with the

clearing of the banks in conjunction with the Piscatorial Society.

Horley in Bloom and South and South East in Bloom were yet again a great success for Horley. In South and South East in Bloom we achieved a Silver Gilt for Horley Recreation Ground and improved on the Silver for the Town Centre last year, by achieving a Silver Gilt this year. Once again the hanging baskets in the Town were beautiful and admired by many and last year we had an addition of sponsored tiered planters which will we have again this year. Should anybody wish to sponsor any town centre flowers, please contact Carol Fenton our Deputy Clerk.

I was very proud of how immaculate the Memorial Gardens looked this year with the lovely stripes on the grass and the well-tended beds. Thanks to Countrywide Ground Maintenance.

Reigate & Banstead Borough Council continues to carry out a large part of our grounds maintenance and officers and staff are always very quick to respond to any queries we may have.

Playground inspections are being carried out by Bennetts and Sons and this is working well. Thankfully this year other Councillors have been assisting me in my weekly inspections of the play areas and Park as the increased number of parks and open spaces has become too much for one person! I thank those other Councillors for their assistance.

As ever the allotments were superb, if possible, even better than last year.

Things have continued to improve this year despite financial constraints but we still have more to do and will continue do them prudently. We do have some major projects on the horizon such possible improvements to the skateboard park at Horley Recreation Ground and improvements in Church Meadow with the planting of the wild meadow flowers and the continuation of the wild flower planting at Horley Recreation Ground and Emlyn Meadows.

Hopefully Bay Close will soon have permanent goal posts installed, following planned consultation with local residents.

### PLANNING & DEVELOPMENT COMMITTEE REPORT

The Town Council is a legal consultee on all Planning Applications within the parish boundary and the Planning & Development Committee acts for the Council on these matters.

The Committee also considers any planning matters from neighbouring authorities such as Crawley, Mole Valley and Tandridge Borough and District Councils, which may have an impact on the town and its residents.

The Committee is also responsible for the following:-

### **Gatwick Airport**

During the past year we have strengthened our relationship with Gatwick Airport Ltd [GAL] through our membership of the Gatwick Airport Consultative Committee [GATCOM]. This gives us access to their senior management and the opportunity to be involved with briefings and seminars on airport related matters. We will work to maintain and improve these relationships, as events at Gatwick can have a significant impact on Horley. We also, through GATCOM, sit on the Ground Noise Monitoring Committee and the Noise and Track Monitoring Advisory Group.

### Highways:

We continue to meet Highways officers on a regular basis as well as encouraging residents to report all highways complaints via the Town Council, as this enables us to build up a picture for Horley which is used in our meetings with the officers. In addition reports to Surrey County Council are copied to our County Council members Kay Hammond and Dorothy Ross-Tomlin.

This Council monitors the highways department's roads programme to ensure that Horley receives its share of spending on major works such as road resurfacing. We are conscious of residents' concerns regarding the phasing of the traffic lights at the Victoria Road/Consort Way East junction, following the introduction of the pedestrian controlled crossings. The Chairman of the Council has written to the Leader of Surrey County Council expressing our concerns and dissatisfaction at the response of officers. At this time discussions between the two Councils are on-going and we look forward to a satisfactory conclusion.

### **Railway Matters**

Whilst improvement works have been carried out on the subway, we have yet to be satisfied that all of the issues have been resolved and we will continue to work with our partners at the Borough Council for a successful and long lasting outcome.

### **Horley Regeneration**

I am happy to report that the Regeneration Forum now meets on a regular basis. Work in the North East sector has made significant progress in the past year with phase one nearing completion and work beginning on phases two and three. We are encouraging the developers to speed up the construction of the community centre element such as the shops as we believe this will introduce a sense of community for our new residents.

It is planned that the Town Council will assume responsibility for the management of the Community Centre at Tanyard Barn.

Little progress has been evident in respect of the North West development although the latest reports indicate that the developer has now secured the land with the exception of one owner.

The most high profile part of Horley's regeneration this year has been the completion of the new leisure centre in Court Lodge Road. The facilities offered are first class and are proving to be very popular with residents from Horley and the surrounding area. This area is becoming the main hub for sporting activities in the town sharing, as it does, a site with the football and rugby clubs. Nearby are the Town Council's football pitches, which are considered to be amongst the best in the area.

There is little to report on regeneration in the town centre however the main focus in the near future would appear to be the re-development of the Newman House site which is under the ownership of the Borough Council.

Another welcome development, after many years of negotiation, is the sale of the former Court Lodge Infants School site, due to become a care home and new Baptist Church.

Following the publication of Gatwick's Draft Master Plan this Council has recognised that, over the years, the commercial benefits to Horley have been eroded with many major aviation companies moving out of the town as part of global decisions regarding office locations.

It is our intention to redress this, highlighting Horley's close proximity to Gatwick as an ideal location for companies whose activities are allied to the airport, as well as the town's prime geographical position with good transport connections to a major airport, a frequent train service to London and easy access to the motorway network. To this end we have already held discussions with CADIA (Gatwick Diamond) the local business forum to assist us in identifying the needs of the business community. Thereafter we will be working with our partners at the Borough Council to design an ongoing strategy. Our aim is to attract new businesses and encourage existing ones to grow, thereby providing jobs for our residents and benefits in general to the local economy.

### **Local Transport:**

Following a flurry of activity last year I have nothing to report on local transport matters other than to say that GAL is consulting on its proposals for rail services to the airport and how these can benefit local communities. This will be followed up by a review of coach and bus services. In this your Council will continue to play a full and active part.

As can be seen, this has been another busy year for the Committee. As Planning Applications do not recognise holiday periods, when necessary, a sub-committee considers urgent applications for ratification by the full committee at the next meeting. We have continued to make good progress in our transformation to a paperless system with more members of the committee using electronic devices such as lap tops and ipads. This has shown some shortcoming in our internal computer systems which we hope to address in the coming financial year.

We continue to see, and welcome, an increase in the number of residents using the public forum part of our meetings to address Councillors on matters of interest or concern to them and their neighbourhoods.

Such has been the interest from members of the public in our comments on planning applications, we now publish these on our web site, along with our responses to consultations.

With this being the first year of a new administration, training for new members and refreshers for longer serving members has assumed a greater importance. We continue to attend seminars at the Borough Council and have introduced a programme for member training. Subjects covered include air quality, tree preservation orders, highways and planning enforcement.

This coming year we will be seeing the effects of the introduction of the Localism Bill and the National Planning Policy Framework, both of which will have a major impact on the planning process. This Council will work to identify the benefits this legislation may offer and how we can use this to improve matters for the residents of Horley. Councillors and staff are currently undergoing training on the new legislation.

In conclusion I would like to thank my Vice Chairman Councillor Tony Schofield and all members of the committee for their hard work and support throughout the past year. My thanks, also to the Clerk and staff, without whose support our job would be impossible.

### DEVOLVED POWERS

### Introduction

In January 2011 Horley Town Council entered into an agency agreement with Reigate & Banstead Borough Council for the provision of grounds maintenance services in Horley until March 2015.

Both parties had previously planned to devolve a number of specific services from the Borough Council to the Town Council. This was a direct result of Horley Town Council achieving Quality Status followed by a Partnership Agreement made between the two Councils in April 2009. The Borough Council agreed to consider any functions where devolution would offer best value (taking into account cost, quality, local preferences and practicability). This has ensured that the following criteria are met:

- Deliver an improvement in service
- Improve service resilience
- Make it simpler for the resident
- Make a more inclusive service

The following parks and recreation areas were transferred to the management of Horley Town Council in 2011:

Bay Close Open Space Church Meadows Riverside Garden Park Riverside Walk Yattendon Road Recreation Ground

### Parks and Recreation Grounds in Detail

The general standard of work has been highly satisfactory. Consultation with local residents and park users has been made on a variety of issues. It took some time before members of the public were fully aware of the Town Council being the first point of contact, despite the initial publicity. Newly installed signs gradually increased public awareness of the change of roles.

### **Bay Close Open Space**

We have liaised with residents and, subject to further consultation, plan to install permanent five-a-side football posts. The adjacent scout hut is not managed by the Town Council and appears to be used only for storage.

### **Church Meadows**

Following discussion with park users and consultation with other agencies, including the Gatwick Greenspace Partnership, it was agreed to increase the amount of short grassed areas and to plant yellow rattle to encourage the growth of wild flowers in the long grassed areas.

### Riverside Garden Park

Much clearance work has been carried out, following consultation with the Horley Piscatorial Society, Gatwick Greenspace Partnership and Reigate & Banstead Borough Council. New benches and litter bins have also been installed.

### **Riverside Walk**

The area is regularly monitored and any issues such fly tipping are speedily dealt with.

### Yattendon Road Recreation Ground

New playground equipment has been installed, following site meetings with contractors. Existing football posts have been removed, due to their rusty unsafe state. The area is to be monitored, with a view to installing new five-a-side goal posts later this year. As with all other playgrounds looked after by the Town Council, our contractor, Bennett & Sons, carries out detailed weekly and daily visual inspections of the playground equipment.

Town Councillors have made regular visits to all these sites and have reported any issues. As with all our open spaces, litter collection is now carried out on a daily basis. Following the introduction of new signage, the Town Council has dealt with all operational gueries from members of the public.

In addition to the parks, the Town Council has also assumed responsibility for all the planters and hanging baskets in the town centre. Sponsorship is regularly sought from local businesses and the area is entered into the South & South East in Bloom competition.

### Lessons learnt

The first year has enabled both authorities to work together. The agency agreement has allowed Horley Town Council to select its own contractors to carry out the variety of maintenance schedules. Contractors employed for specific duties are as follows:

# ENVIRONMENT CAMPAIGN



Following Horley Town Council's 2010 Environment Week, which was strongly supported by Reigate & Banstead Borough Council, Councillor Joan Spiers asked our team to organise a similar campaign across the Borough during 2011. We approached the task by forming a strategy team made up of officers and Councillors, both from the Borough and Horley Town Council. An action plan was produced and all Councillors were briefed.

### **Campaign Aims:**

The environmental topics chosen to raise awareness were – recycling, energy reduction, reduced water consumption and elimination of the free supermarket plastic bags.

### **Community Engagement – Horley:**

The Horley Environment Campaign was planned to run from Saturday, 24th September to Friday 30th September (excluding Sunday) at Waitrose. Thanks to Waitrose, we were able to set-up a stall in their foyer and a plentiful supply of re-useable bags was made available for distribution. The campaign got underway with a massive response to a request for volunteers, with in excess of 100 hours of community engagement time pledged. By the end of the week, we had collected 1,100 more pledge sheets with shoppers making numerous pledges to improve their green behaviour.

At 8.30 am on day one, the Recycling Road show rolled into Waitrose car park and set up shop in the Drop Off zone. For the rest of the day, it was difficult to see it for interested visitors. The day commenced with Dorothy Ross-Tomlin, and Simon Marshall with his Chain of Office, catching shoppers at what seemed to be Saturday's peak period. We can say with great pride that every Town Councillor, Horley Borough and County Councillors gave of their time during the week. We extend our gratitude to Councillor Rita Renton for coming to Horley from her own community to help out. Thanks must go to several Horley residents who also helped out. What was creditable was the amount of voluntary time given working throughout Saturday, 24th September and late into the evening on most days. Could we be seeing the birth of a Big Society approach towards our community's needs? There was one surprise when both David Powell and Allan Kay received kisses from a very effusive lady. We are not sure if it was Allan's good looks or David's aftershave! Thursday 29th September was our big day in action at Waitrose with a visit to our team by Sam Gyimah MP, and our two Mayors; Town Mayor Cllr Simon Marshall and Borough Mayor, Cllr Brian Stead. They were accompanied by Cllrs Graham Knight and Alan Kay, both members of the Borough Council's Executive Committee, and John Jory, the Borough Council's Chief Executive. This was a very strong group, especially when they were joined by Calvin Gilbey, Waitrose Store Manager, and his deputy, Paul Placitelli, for a photo call in the store foyer.

On Friday 30th September, the final day, a record 180 pledges were achieved bringing Horley's total for people interviewed during the week to over 1,100. This number included families from South Africa, USA, Spain and France. David Powell was interviewed on screen by a couple from North Carolina.

### **Horley Happy Dogs Day**

The Town Council also organised a Dog Training day or "Doggie Fest". The dog obedience display was enough to have Mrs Woodhouse doing cartwheels. It was very amusing to see Amy the Boxer seeking to play with a Jack Russell look-alike and kiss anyone willing. Full marks went to Caroline Grant, the Borough's Dog Warden, who spent the afternoon on her knees inserting micro-chips into 10 dogs.

The Town Council and the Community Foundation for Surrey continue to receive enquiries about the Horley Edmonds Community Fund. Using the Foundation's expertise other donors are able to be approached.

### **Notes**

In 2007 the Town Council was left a substantial sum of money in the will of Cyril Edmonds, a builder who lived at Norwood Hill.

The Town Council subsequently explored a number of options, followed by a full public consultation conducted from June to October 2007. This was carried out via press releases and articles in the Town Council's newsletter and on its website. Many members of the public were in contact with the Council and we received a number of very interesting suggestions. The Council also listened to presentations made by the trustees at its public forum at the Full Council meeting on 6 November 2007.

The preferred option was to set up a permanent fund which would generate sufficient interest from the capital sum to provide funding for outings, theatre trips, holidays, etc. for the benefit of underprivileged and needy residents of Horley.

In July 2008 the Town Council appointed the Surrey Community Foundation to manage the main element of Fund and achieve the objectives as outlined above.

### TOWN AWARDS

### 2011 Veronica Ballard

Veronica was a teacher at Burstow Primary School for 37 years and Secretary / Chair Person of Horley Surrey Girl Guiding for over 45 years. She was awarded the Gold Duke of Edinburgh Award as well as other Long Service Awards. A member of Horley Local History Society & Camera Club, setting up local exhibitions, giving talks and writing history books. Veronica was also a CAB Advisor and behind the scenes volunteer at the Archway Theatre. Veronica is a dedicated volunteer and her keen interest in local history together with her many camera skills encourages people she meets to open their minds and learn.

### Alison Brice

A former CAB Advisor, assisting older people to claim benefit entitlements and deal with various problems. A member of Regent Hall Management Committee, giving important advice to the management staff on a range of issues. She founded the Regent Hall Book Club and, although she later lost her sight, she has continued to organise the Book Club meetings. She gives voluntary support to everyone at Regent Hall especially those who are faced with letters and completing forms. She gives so much of her own time and expertise to the benefit of so many people.

### 2010 Dr Jim Williamson

Jim is warmly remembered for his kind and compassionate manner as a GP. He was a School Governor at Sangers Junior School and continues his association with the area as a judge for the Court Lodge in Colour competition, as well as being involved with both the Horley in Spring and Horley in Bloom events. He also served as Chairman of the St Barts Churchyards Committee.

### Kathleen Tremble (posthumous Award)

Kathleen was a passionate supporter of literacy and, as a volunteer at Court Lodge, Sangers and Manorfield Schools, helped a great many Horley children learn to read. Kathleen was active in the development of Manorfield School and for nearly thirty years served as a Local Education Authority Governor, until just before her death in March 2010. Kathleen was also active in the initial setting up of the Horley Learning Partnership, one of the first such confederations in the country.

### 2009 Tom Anglim

Tom spends a great deal of his time working for local organisations and also works at the Tadworth Court Children's Hospital shop one day a week. In 1969 he attended the air crash at Fernhill and was subsequently awarded the Queen's Award for Bravery. Tom has shown great courage and determination in the face of a painful and debilitating illness and gives his time freely and cheerfully to help others.

### 2008 Robert Garfitt

Robert has served the people of Horley as both a Borough and a Town Councillor. He was Mayor of Horley Town Council from 1988-1989 and Deputy Mayor of Reigate & Banstead Borough Council from 1990-1991. Robert has also served as a Justice of the Peace for many years.

### **Andrew Partridge**

Andrew has served as a school governor for almost 25 years and has spent much of his time helping Horley's young people. He has been a committee member of the Horley Vimy Twinning Association since its inception and has worked tirelessly to promote Horley's link with Vimy. As a member of the Horley Lions, Andrew has helped raise around £20,000 per year for local charitable causes.

### 2007 Andrew Kent

Andrew has worked tirelessly to improve and protect the local environment, bringing great knowledge and commitment to this role. His methodical, patient and immensely detailed work on the Horley Master Plan has been outstanding. He has served on the Horley Master Plan Task Group and the Horley Master Plan Advisory Committee. Andrew coordinated responses to the Local Plan, the County Structure Plan and presented evidence at Inquiries. He was instrumental in producing documents on flood risk in Horley.

Previously Chairman of the Horley Residents' Association 1993 - 2007 and a Horley Town Councillor from 1996 - 2007.

### 2007 Alan Tracey

Alan was the longstanding Chairman of the recently disbanded Police & Community Partnership Group, ensuring over the years that the people of Horley had meaningful direct contact with the local Police. He is also Secretary of the Naval Section of the Royal British Legion.

He has worked hard for the Archway Theatre and has tirelessly supported both Cooper Lodge and the Brambles Respite Care Centre, in his role as a volunteer entertainer.

### 2005 Barbara Hall

In recognition of Barbara's support of local charitable organisations for more than forty years. Barbara has been a member of the patients committee at the Kings Road Health Centre for many years and has recently become a non-executive director for the NHS East Surrey PCT and is also actively involved with Open Line through the Horley Help Shop

### 2005 David Hall

In recognition of David's outstanding voluntary work and charity work, as well as being a School Governor and a former member of Surrey County Council.

David has been Chairman of the Horley Local History Centre, based in the Library, and is very involved with the Local History Society. He also continues to conduct his own research into the town's history.

### 2005 John Melvin

John has been an active member of the Horley Lions Club since 1974 and has been President on three occasions: 1976 1982 and 2003.

Since his retirement in 1982 he has spent much of his time sorting the many paperback books which are sold on the Lions Bookstall in the town centre each Saturday.

2011/2012




